**BUDGET ADOPTION**

Mrs. Laura Boldery, Treasurer/Assistant to the Superintendent stated that this was the adoption meeting for the 2021 budget. She asked the Board and attending audience if they had any questions or comments at this time. Mrs. Boldery stated we are advertising the following budgets:

Upon a motion by Mrs. Deputy and seconded by Mr. Jones, the Board voted by roll call vote 4-0 to approve Resolution 2021-03 to Adopt the School Bus Replacement Plan.

Upon a motion by Mr. Jones, seconded by Mrs. Deputy, the Board voted by roll call vote 4-0 to approve Resolution 2021-04 to Recover Unreimbursed Costs of Textbooks.
